Accreditation: Mandatory Continuing Legal Education

The Suffolk Academy of Law is certified by the New York State Continuing Legal Education Board as an **accredited provider of continuing legal education in the State of New York** and also as an **accredited provider of video and audio recordings**.

MCLE Credit for Recorded Programs

The Academy requires attorneys who wish credit for recorded CLE to complete a simple **program evaluation/questionnaire** that includes a request for program-specific comments. Users must also report (in the space provided on the form) the **verification code** that is shown or spoken during the course of the program. Upon receipt of a completed evaluation form, the Academy issues a **certificate of completed CLE activity**. Under the rules of the NYS CLE Board, lawyers are required to retain these (and all other certificates of attendance or completed CLE activity) in their personal records for at least four (4) years.

Catalog Listings

Most of the programs listed in this catalog were presented live during the Academy's 2007-2008 academic year. This catalog also includes some programs from earlier years that continue to have relevance for practitioners. Recorded programs are grouped by substantive area, and each entry is identified by date of the live program. MANDATORY CONTINUING LEGAL EDUCATION IN NEW YORK

NEW LAWYERS

32 credits during first two years of practice: *must take minimum of 16 in first year; may take up to 24 during first year and bank a maximum of eight toward second year.* -- New lawyers should take courses designated as "*transitional training*" or "*bridge-the-gap.*" Requirements are broken into credit categories: minimum of seven credits *each year* in **professional practice** (substantive law or practice management); minimum of six credits *each year* in **skills**; minimum of three credits *each year* in **ethics/professionalism**. Ethics credits *cannot* be banked; other credit areas can be. **NEW LAWYERS MUST TAKE CLASSES IN TRADITIONAL, LIVE SETTINGS.**

VETERAN LAWYERS

24 credits during *each* biennial registration period. -- At least four of the credits must be in ethics/professionalism; the remaining credits can be comprised of any categories (skills, substantive law, practice management, or *additional* credits in ethics). Veteran lawyers may bank a maximum of six credits from one reporting period to the next. **VETERAN LAWYERS MAY FULFILL THEIR MCLE OBLIGATIONS WITH COURSES OFFERED IN NON-TRADITIONAL FORMATS, INCLUDING AUDIO OR VIDEO RECORDINGS.**
